
CERTIFICATE OF AMENDMENT
TO THE DECLARATION OF
ALAMANDA KEY

Pursuant to the provisions of the Declaration of ALAMANDA KEY, as recorded in Official
Records Book 5423, Page 2393, Public Records of Brevard County, Florida, ALAMANDA KEY,
LLC hereby amends the Declaration as follows:

1. Article 2.5 (d) of the Declaration is amended to provide as follows:

(d) Motorcycles, motorbikes, scooters, go-peds, ATVs and all other forms of motorized, two-wheeled, or off-road vehicles may not be operated on any Lots, roadways, alleys, common area or elsewhere within the Subdivision. However, battery-operated four-wheeled personal transport devices may be used as necessary by persons having a disability, as the same is defined under the Americans With Disabilities Act of 1990, as amended. Notwithstanding the foregoing, motorcycle owners residing in the Subdivision may, in the sole and unfettered discretion of the Board, be granted terminable written consent to use and operate a motorcycle in the Subdivision. Such Board consent shall not be effective unless given in writing, and may be withdrawn at any time, by written notice to the party to whom consent was granted. Withdrawal of consent shall not require cause, and such withdrawal shall be at the sole and unbridled discretion of the Board. Once consent is withdrawn, the subject motorcycle will be subject in all respects to the foregoing prohibition regarding same. The written consent of the Board referred to herein may contain qualifications and conditions relating to the use, operation, and storage of the subject motorcycle.
